The Eardoc™ is a **safe, simple, efficient** and **non-invasive** device that solves the problem, rather than treats the symptoms.

The Eardoc™ is a device designed to open the ear tube and allow fluid and air to drain, for adults and for children. Divers and air travelers that suffer from the pressure know this accumulation of fluids and air too well. The Eardoc™ helps drain fluids and air, lessening the pressure on the eardrum, allowing instant relief of the ear pain – no pills needed.

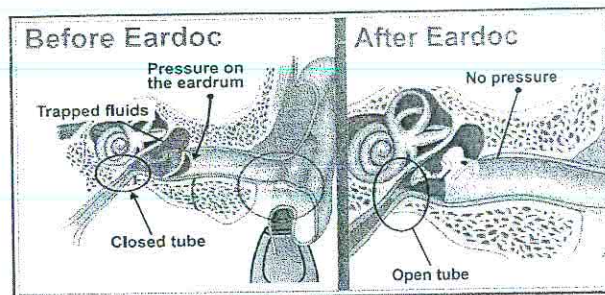
How does Eardoc™ work: Eardoc™ generates and transmits vibration waves through the mastoid bone to the Eustachian tube. This allows the Eustachian tube to open in a non-invasive drug free way. The waves opening the Eustachian tube allow drainage of the trapped fluids and air, and ease the pressure.

The Eardoc™ is a safe and simple treatment for:

- Otitis Media
- Trapped fluids and air in the middle ear
- Eustachian tube dysfunction
- Air travelers with ear pressure during landing/Take-off.

How to use the Eardoc™:

Insert 2 AA batteries according to signs (+) and (-) on the batteries and tray. Insert batteries in to the Eardoc™ battery tray and close the lid.

1. Turn on Eardoc™ by pressing the upper button. This will turn on the Eardoc™ and the blue light on the Eardoc™.
2. By pressing the upper button, the strength of the vibrations will increase. The Eardoc™ has 6 available speeds.
3. Place the Eardoc™ behind the ear (see diagram on the right).
4. Set the speed to a comfortable strength using the buttons.
5. After use, turn the Eardoc™ off by pressing the lower button until it stops and the light turns off.

The Eardoc™ research: the Eardoc™ was studied in a European university. The study checked children with an audiometer – a device that checks the fluids in the middle ear. The study shows significant reduction of middle ear fluids.

All the children in the research had Ear infections and/or fluids accumulated in the middle ear. Group A are children with ear infections but without fluids. Group B are kids with middle ear infections and/or fluids treated by Eardoc™. As seen on the left, the number of healthy children in group A decreased while in group B the healthy children number increased significantly while using the Eardoc™.

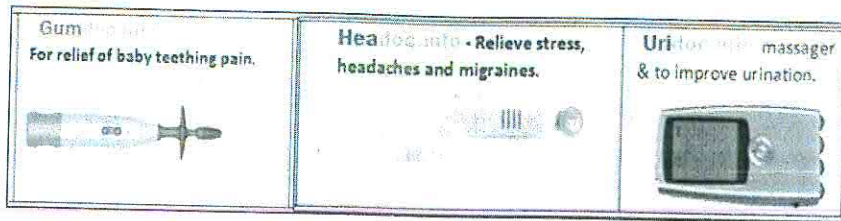

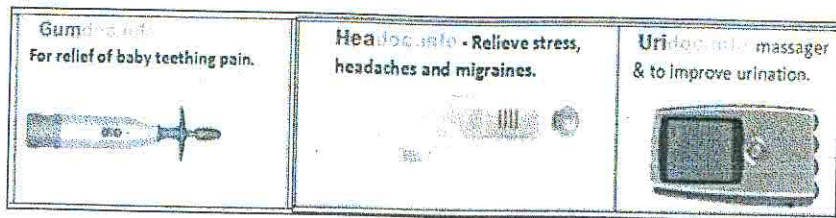
